I, Joyce Allen, being duly sworn state the following:

- My name is Joyce Allen. I am a resident of Montgomery County, North Carolina. I am over the age of 21 years and competent to make this statement. My statement is based upon my personal knowledge.
- 2. I met Scott Allen on a beach trip with Larry Smith and my sister, Lois. Scott and I eventually married and had a daughter, Jordan.
- 3. Scott and Chris Gailey met in high school and hung out a lot after they left school. Chris came to live with Scott and me in 1992 or 1993 when we were living in Sophia, North Carolina.
- 4. After I broke up with Scott, I lived with Chris for a short time in 1999. Jordan was five years old, and she stayed with Scott's parents, Benny and Sherry Allen, every other week. The week Jordan was with Benny and Sherry, Chris would stay with me. The other week he stayed at the lake house with Scott, Vanessa Smith, my brother Robert, and some others. The lake house was basically a party house.
- Vanessa was in love with Scott. She was obsessed with him. She was very angry that Scott had gone back to Colorado to be with Kelly. When Vanessa returned from Denver, she told me to tell Scott to come get her or she would "make his life miserable." Shortly after that, she went to the police.
- 6. I knew Chris carried drugs and a lot of money. When Chris started doing cocaine, his whole attitude changed. He was distributing. He would go days without sleeping. He would not let anyone drive his truck. I do not know, however, who he got his drugs from.
- 7. I tried to talk with Chris about his use of cocaine. He blew up at me. Where ever he went, he would lay out the cocaine, cut out a rail, let everyone in on it. He would get people going, then begin charging for it. I did ask him to keep the cocaine out of our house, so Jordan wouldn't get into it or get it on her.

- 8. I tried to talk with Vanessa Smith after Scott's trial. She told me not to ever talk to her again about it. She just closed off.
- 9. I will always love Scott. Scott told me that he liked me, but that I wasn't his type of woman. I guess that is why he went off with Vanessa Smith, and then Kelly Racobs. Scott was not at all upset about my relationship with Chris. He was not jealous at all.
