ON NOVEMBER 3, 1999 JEFFERY PAGE CAME TO THE MONTGOMERY COUNTY SHERIFFS OFFICE WITH HIS ATTORNEY ROBERT SLAUGHTER. POOLE TOLD PAGE HE WAS UNDER ARREST AND THEN ADVISED HIM OF HIS MIRANDA RIGHTS. PAGE STATED THAT HE UNDERSTOOD HIS RIGHTS BUT HE WANT HIS ATTORNEY PRESENT. PAGE SIGNED A WAVIER OF HIS RIGHTS AND HIS ATTORNEY WAS PRESENT FOR THE FOLLOWING INTERVIEW.

PAGE STATED THAT ON JULY 10, 1999 THAT HE AND JOHN BLACK WENT DOWN TO SHALLOTTE NORTH CAROLINA TO HIS FRIEND SPIDERS RESIDENCE.

PAGE STATED THAT HE DROVE HIS WHITE HONDA DOWN.

PAGE STATED THAT WHEN THEY GOT THERE THAT SPIDER WAS HAVING A COOKOUT AND THERE WAS A FEW PEOPLE THERE.

PAGE STATED THAT WHEN A WHITE MALE NAMED SCOTT ALLEN WAS THERE WITH VANESSA SMITH.

PAGE STATED THAT SMITH IS FROM STANLY COUNTY AND A FRIEND OF SPIDERS.

SPECIAL NOTE: POOLE SHOWED PAGE A PICTURE OF SCOTT DAVID ALLEN, AKA BYRON JAMES JOHNSON AND PAGE POINTED AT THE PICTURE AND STATED THAT IS SCOTT.

PAGE STATED THAT LATER IN THE NIGHT HIS SELF, JOHN BLACKWELDER, ROBERT PERALTA, AND SPIDER WAS TALKING WITH SCOTT ALLEN.

PAGE STATED THAT SCOTT ALLEN TOLD THEM THAT HE HAD SHOT SOME BOY THE OTHER NIGHT IN THE WOODS AND THEN STOLE HIS TRUCK AND THAT THE TRUCK WAS OUTSIDE.

PAGE STATED THAT SCOTT ALLEN TOLD THEM THAT HE USED A SHOTGUN AND SHOT HIM A FEW TIMES AND THAT HE HAD TO WAIT A FEW HOURS FOR THE BOY TO DIE.

PAGE STATED THAT SCOTT ALLEN TOLD THEM THAT HE COULD HEAR THE BOY MOAN SO WHEN HE COULD NOT HEAR THE BOY HE SHOT HE WOULD THROW ROCKS AT HIM TO MAKE SURE IF HE WAS ALIVE.

PAGE STATED THAT SCOTT ALLEN TOLD THEM THAT THE REASON HE KILLED THE BOY WAS BECAUSE THE BOY WAS GOING TO RAT HIM OUT.

PAGE STATED THAT SCOTT ALLEN TOLD HIM HE WANTED TO SELL THE TRUCK.

PAGE STATED THAT HE HAD ALREADY LOOKED AT THE TRUCK AND THAT IT WAS A GMC FULL SIZE, WHITE IN COLOR AND ALMOST NEW.

PAGE STATED THAT HE ASKED SCOTT ALLEN HOW MUCH DID HE WANT FOR THE TRUCK AND SCOTT ALLEN TOLD HIM \$800.00.

PAGE STATED THAT HE THOUGHT IT MIGHT NOT BE TRUE ABOUT THE TRUCK HAD BELONGED TO A VICTIM OF A HOMICIDE CASE THAT HE THOUGHT THE TRUCK WAS JUST STOLEN.

PAGE STATED THAT HE TOLD SCOTT HE WOULD BUY THE TRUCK FOR THAT BUT HE HAD TO GO BACK TO STANLY

COUNTY TO GET THE MONEY AND SCOTT ALLEN TOLD HIM OKAY.

PAGE STATED THAT SCOTT ALLEN TOLD HIM HE WOULD MAIL HIM A TITLE FOR THE TRUCK TO SPIDERS HOUSE LATER.

PAGE STATED THAT THE NEXT DAY ON SUNDAY JULY 11, 1999 THAT HE GOT ROBERT PERALTA TO DRIVE THE TRUCK BACK TO STANLY COUNTY FOR HIM AND JOHN BLACKWELDER RODE WITH HIM.

PAGE STATED THAT HE DROVE HIS HONDA AND SPIDER RODE WITH HIM AND ROBERT DROVE THE TRUCK AND FOLLOWED HIM BACK TO STANLY COUNTY.

PAGE STATED THAT HE HAD ROBERT TO FOLLOW HIM TO A FRIEND OF HIS IN STANLY COUNTY NAMED EDDIE HOWARD AND EDDIE HAS A SON NAMED BYRON HOWARD.

PAGE STATED THAT EDDIE AND BYRON LIVES ON OLD WHITNEY ROAD IN STANLY COUNTY.

PAGE STATED THAT HE GOT ROBERT TO PARK THE TRUCK OUT BACK OF EDDIE'S HOUSE IN A FIELD TO HIDE THE TRUCK BECAUSE HE KNEW THE TRUCK WAS HOT.

PAGE STATED THAT EDDIE WAS NOT AT HOME BUT BYRON WAS AND THAT HE TOLD BYRON THE TRUCK WAS HOT AND THAT HE NEEDED TO LEAVE IT THERE FOR A FEW DAYS AND BYRON TOLD HIM OKAY.

PAGE STATED THAT ROBERT AND JOHN GOT IN HIS CAR IN THE BACK SEAT AND SPIDER WAS IN THE FRONT PASSENGER SEAT AND THAT HE DROVE HIS HONDA BACK TO SHALLOTTE.

PAGE STATED THAT HE BOUGHT A CASE OF BEER IN STANLY COUNTY.

PAGE STATED THAT THEY DROVE TO HIS MOTHERS HOUSE IN STANLY COUNTY BEFORE GOING BACK TO SHALLOTTE AND THAT HE WENT INSIDE AND GOT \$800.00 OUT OF THE SAFE TO PAY FOR THE TRUCK.

PAGE STATED THAT HE WENT OUTSIDE AND GAVE THE MONEY FOR THE TRUCK TO SPIDER AND THEY ALL WENT BACK TO SHALLOTTE AND THAT SCOTT ALLEN WAS STILL AT SPIDERS HOUSE.

PAGE STATED THAT SPIDER GAVE SCOTT ALLEN THE \$800.00 FOR THE TRUCK AND THAT SCOTT WAS TALKING TO THEM ABOUT HE WAS GOING OUT WEST TO GET AWAY FROM THE POLICE.

PAGE STATED THAT HE LEFT THAT NIGHT AND THAT HE THINKS SPIDER TOOK SCOTT ALLEN TO THE BUS STATION.

PAGE STATED THAT ABOUT (1) WEEK LATER THAT HE STARTED TO HEAR ABOUT THE BOY GETTING MURDERED AND ABOUT THE TRUCK THAT WAS STOLEN FROM HIM.

PAGE STATED THAT HE KNEW EDDIE COULD GET RID OF THE TRUCK EVEN IF IT WAS INVOLVED IN A HOMICIDE AND THAT THE TRUCK WAS STOLEN.

PAGE STATED THAT HE WENT AND TALKED WITH EDDIE SHERIN BECAUSE HE SAW BYRON HOWARD AND BYRON TOLD HIM THAT HIS DAD WANTED THE TRUCK MOVED.

PAGE STATED THAT HE TALKED WITH EDDIE SHERIN AND TOLD EDDIE THAT THE TRUCK WAS STOLEN FROM SOME GUY THAT HAD BEEN KILLED.

PAGE STATED THAT EDDIE KNEW THE TRUCK WAS HOT AND THAT EDDIE TOLD HIM HE COULD SELL THE TRUCK.

PAGE STATED THAT HE TOLD EDDIE HE NEEDED AT LEAST \$800.00 FOR THE TRUCK AND EDDIE MADE A PHONE CALL TO SOMEONE TO SELL THE TRUCK.

PAGE STATED THAT A FEW DAYS LATER HE USED HIS MOTHERS CAR AND WENT AND PICKED UP EDDIE AND WENT TO WHERE THE TRUCK WAS AT.

PAGE STATED THAT EDDIE DROVE THE TRUCK AND HE FOLLOWED EDDIE.

PAGE STATED THAT HE FOLLOWED EDDIE TO SOME JUNK YARD IN CONWAY SOUTH CAROLINA.

PAGE STATED THAT HE SIT IN THE CAR AND EDDIE WENT INSIDE AND MADE THE DEAL.
