I, Joseph B. Loflin, being duly sworn state the following:

Davidson JUS My name is Joseph B. Loflin. I am a resident of Montgomery County, North Carolina. I am over the age of 21 years and competent to make this statement. My statement is based upon my personal knowledge.

- Back in the late 1990's, I was friends with Tina Fowler (now Tina Fowler 2. Chamberlain) and Tonya Monk, both of whom I knew from the Badin Lake Boat and Tennis Club where they worked. I also knew a young woman named Amy Little who managed the club. I never had a romantic relationship with any of these women, but we were good friends.
- Tonya Monk passed away several years ago. I saw Tina at the funeral. 3.
- I recall giving Tonya a ride from the Badin Lake Boat and Tennis Club to 4 Tina's house a number of years ago. I was driving a 1989 Mercury at the time. It was around nine or ten o'clock in the evening and was completely dark. Tina's residence was located just down the road from my house and not out of my way.
- When Tonya and I got close to Tina's house, I could see that there was an 5. older model Oldsmobile or Buick-type car parked in the driveway near the residence. Tonya told me to let her out and she would walk up the road to the house. She asked me to wait for her. I stayed in the car and waited to make sure everything was alright.
- After a few minutes, Tonya waved at me to come up to the residence. I drove 6. up the drive and angled my car so I could see inside the car parked near the residence. Tonya was talking to a slim white male, who appeared to be fairly tall. The driver's window was rolled down, and the man's arm, hanging on the door, had several tattoos. There was another person in the car on the passenger side, but I could not see that person very well.
- Tonya got back into my car and told me that the guy with the tattoos was "on 7. the run." This, of course, concerned me greatly. Tonya also told me that the

reason she got out of my car and walked up the drive was to tell the guy, whom she knew, that I was "alright." Because of my concern, I gave Tonya a ride back to the club.

8. At the time of this incident, I could not understand why Tonya and Tina were messing with a guy like that. I later learned that Tina had gone to school with him and had known him for a number of years.
